FRIM PCS

FRIM Product Certification Services (FRIM PCS) was established in June 2013 and approved under the special powers of the Minister of Natural Resources and Environment on November 18, 2014 as an addition to the Malaysian Forestry Research and Development Board Act 319 (1985).

Frim was accredited the ISO/IEC 17065:2012 (Conformity Assessment-Requirement for Bodies Certifying Product, Processes and Services) from Department of Standards Malaysia on 12 December 2014, and recognised as the eight product certification body in Malaysia.

Following the gazette of FRIM ACT 782 on 1 October 2016, FRIM PCS has been playing on extensive role as a product certification body for forest resources and products.

OUR MAIN AIMS:

- i. To assist the local industry in the productive of product consistently;
- ii. To ensure the wood industry meet the required specification and standard determined by stakeholders and consumers;and
- iii. To assist the wood industry in the production of products which meet the standard demanded by the local and international market.

MyHijau

FRIM PCS has been a partners for MyHIJAU since 2016. There are four types of green product certifications recognised by GreenTech under the MyHIJAU Scheme,namely:

- (i) Green Label Certification (ISO 14024 Type I Eco-labels)
- (ii) Green Label Certification (ISO 14025 Type III Eco-labels)
- (iii) Green Label Certification (Other type I-Like Voluntary Sustainable Scheme; VSS)
- (iv) Performance Standard Compliance

As a furniture product certification body that certifies products based on the performance test on safety requirement, FRIM is recognised as a partner in MyHIJAU Green Certification for category no.iv. Therefore, companies certified by FRIM can apply for listing as a company under MyHIJAU Directory. GreenTech charges a fee to enable the companies to register and to use the MyHIJAU logo on their products and packaging.

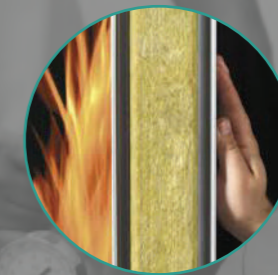
